I/we know of and acknowledge that my child/ward knows of the risks involved in athletic participation, understands that serious injury, and even death, is possible in such participation and choose to accept any and all responsibility for his/her safety and welfare while participating in athletics.

With full understanding of the risks involved, I/we release and hold harmless my child's/ward's school, the schools against which it competes, the contest officials, NWRES D, BVIS Fund, coaches, staff, and Oregon School for the Deaf of any and all responsibility and liability for any injury or claim resulting from such athletic participation and agree to take no legal action against NWRES D, BVIS Fund, coaches, staff, regional programs, and the Oregon school for the Deaf because of any accident or mishap involving the athletic participation of my child/ward.

F. I/we further authorize emergency medical treatment for my child/ward should the need arise for such treatment while my child/ward is under the supervision of the school.
